

PROMOTION TERMS AND CONDITIONS

THESE ARE THE OFFICIAL PROMOTION TERMS AND CONDITIONS. PARTICIPATION IN THE PROMOTION CONSTITUTES ACCEPTANCE OF THESE PROMOTION TERMS AND CONDITIONS (THE “PROMOTION TERMS”).

Definitions:

Participating

Facilities: Cascades Casino Kamloops

Promotion: Swimming in Cash is a promotion in which both Encore member slot players and non–Encore member slot players who are Qualified Entrants are drawn as a result of a mystery seat draw to win Draw Prizes with no purchase necessary. Qualified Entrants are entered with no purchase necessary in order to enter a Draw at any given Draw Time in order to win Cash Draw Prize. See the “How to Enter and Win a Mystery Seat Draw Prize:” Section below for more details.

Promotion

Period: August 19th, 2026 at 10:00 AM PDT to September 25th, 2026 at 8:00 PM PDT

Draw Days: Wednesdays: August 19, 26 September 2, 9, 16, 23
Fridays: August 21, 28 September 4, 11, 18, 25

Draw Times: 7:00 PM and 8:00pm PDT on each Draw Day

Draw Prize(s): A total of twenty-four (24) Draw Prizes will be available to be won for a maximum combined total of twelve thousand (CDN \$12,000) in cash prizes. One (1) Draw Prize will be awarded per Draw time. Total two (2) Draw Prizes will be awarded on each Draw Day. The maximum total prize value available to be won by a Drawn Entrant at a Draw Time is five hundred (CDN \$500) awarded in cash.

Each Drawn Entrant will have the opportunity to choose from a total of ten (10) prize cards each card having a cash prize value located on the back side. The Drawn Entrant will start by choosing two (2) prize cards (“Initial Draw”) which will be turn over to see if the two cash prizes revealed match. If the two cash prizes revealed

matches, then the Drawn Entrant will win the value of the matched prize. If the prizes of prize cards from the Initial Draw do not match, the Drawn Entrant will choose one (1) additional prize card (“Second Draw”) which will then be turn over to reveal a cash prize. If the cash prize revealed in the Second Draw matches one of the original two cash prizes in the Initial Draw, the Drawn Entrant will win the value of the matched prize. If the revealed cash prize in the Second Draw does not match one of the two original cash prizes in the First Draw, the Drawn Entrant will continue to draw additional prize cards one by one until they have revealed two (2) prize cards with matching values. The Drawn Entrant will win the value of the matched cash prizes revealed and not the combined value of the matched cards. For example, if a Drawn Entrant reveals two (2) prize cards with two five hundred (CAD\$500) on each card they will win five hundred (CAD\$500).

All ten (10) cash prize cards are listed in the chart below. Details are listed on “How to Win a Draw Prize at a Draw Participating Facility” section.

- Gateway:** Gateway Casinos & Entertainment Limited
- Draw:** A draw for a Draw Prize at each Draw Time.
- Drawn Entrant:** Qualified Entrant whose ASL number or entry ballot has been drawn, as a result of a Draw at any given Draw Time.
- Gaming Day:** The 24-hour period from 7:00am PT on one day to 6:59am PT the following day during the Promotion Period.
- Qualified Entrant:** An individual who is 19 years of age or older and either a Canadian or American resident, but does not include:
- Employees, agents, successors and assignees of Gateway, its advertising agencies and promotional companies involved in this Promotion (if any), as well as family and household members of the same who reside at the same address;
 - Employees, agent's successor and assignees of BCLC or the participating gaming service provider and their family and household members who reside at the same address;
 - Individuals who have self-excluded or who self-exclude during the Promotion Period and individuals that are barred from a BCLC gaming facility; or
 - Residents of New York, Rhode Island, Florida or Texas U.S.A.
- Winner's Authorization Form:** Such representations, indemnities and releases as Gateway may require in its sole discretion from a Drawn Entrant in consideration of and in order to induce Gateway to deliver a Draw Prize to the Drawn Entrant.

How to Enter and Win a Mystery Seat Draw Prize:

1. Encore membership is not required. For greater certainty, individuals who are not Encore Rewards Card members are eligible to be selected as Drawn Entrants in all Open Mystery Seat draws.
2. Qualified Entrants may enter the Draw by being seated at a slot machine at a Draw Time at a Participating Facility with no purchase/play necessary.
3. Odds of winning a Draw Prize are based on the total number of Qualified Entrants seated at the slot machines at the time of a scheduled Mystery Seat Draw.
4. For certain Mystery Seat Draws, as determined by Gateway in its sole and absolute discretion, a Drawn Entrant will be chosen by selecting the A-S-L number of the designated eligible slot machine at the Participating Site either by paper ballot or by using the Manual Winner

Confirmation function at the designation Draw Time of such Mystery Seat Draws (each, an **“Open Mystery Seat Draw”**).

5. While under surveillance at the Participating Site, two (2) IGCO registered employees will conduct an Open Mystery Seat draw and will select Drawn Entrants manually using paper ballots at each designated Draw Time. The IGCO registered employees will attempt to contact the Drawn Entrant by approach the Drawn Entrant seated at the chosen A-S-L in person on the gaming floor.
6. If there is no individual sitting at or otherwise attending to the selected designated eligible machine during an Open Mystery Seat Draw, the two (2) IGCO registered employees will complete another Open Mystery Seat Draw process to select another Drawn Entrant. The process will be repeated until a present Drawn Entrant is found.
7. The Drawn Entrant will be required to present valid government issued photo identification, answer a skill testing question and complete a Winner’s Authorization Form in the presence of two (2) registered gaming employees, before the Draw Prize can be released. At such time, the two (2) registered gaming employees will record the completed Mystery Seat/Ballot Draw on a printed tracking form and sign their names and IGCO numbers.
8. The Drawn Entrant’s Draw Prize will be determined in accordance with the rules outlined in the Draw Prize(s) section above.
9. All Draw Prizes will be manually paid out in cash by a Slot Attendant or Cashier in the presence of a second IGCO employee.
10. The Surveillance Department will record each Mystery Seat Draw and will hold the footage in its entirety for thirty (30) days.
11. Each Qualified Entrant may win more than one (1) Draw Prize, but only one (1) Draw Prize per Draw Day at the Participating Site.

General Conditions:

1. No purchase is necessary to participate in the Promotion.
2. Encore Rewards membership is not required.
3. All winners must correctly answer the mathematical skill-testing question outlined below before any prize is awarded:

7. Gateway shall have the right to publish the name, location and a recent photograph of the winner(s) without remuneration to them.
8. Gateway reserves the right to not award any prize, in the event that the integrity of all or part of the Promotion is compromised (including, but not limited to, due to computer error, fraud, deception, misrepresentation or misuse).
9. Gateway makes no representations or warranties whatsoever, either expressed or implied, oral or written, in respect to any prize.
10. Gateway is not responsible for any typographical errors in the administration of the Promotion and/or in any promotion related materials.
11. All prizes must be accepted as awarded and are non-transferable. The refusal by a Qualified Entrant to accept any prize releases and forever discharges Gateway from all obligations to that Qualified Entrant in connection with the Promotion, including delivery of any prize.
12. Gateway reserves the right to substitute any prize or portion thereof with one of equal or greater value.
13. All Gateway decisions in relation to the Promotion are final and binding.
